The tenderer should fulfill following pre-qualifying criteria:

1. The tenderer should have minimum turnover of Rs. 9.25 Lac in any one of the immediate three preceding financial years i.e. 2023-24, 2024-25 and 2025-26.
2. The tenderer/ bidder must be Qualified Person (QP)/ Accredited Mining Plan Preparing Agency (MPPA) in accordance with the recognition granted to consultant i.e. for preparation of mining plan u/s 22B of Mineral Concessions (Amendment) Rules, 2020.
3. The tenderer/bidder must have experience of preparation, submission, expert/ peer review, its compliances & approval of Mining Plan of at least one (1) Mechanized opencast Coal/ Lignite mines from Ministry of Coal, Govt. of India through online submission mode.

The tenderer/bidder who have earlier been suspended or banned or whose contract has been terminated by the Company shall not be eligible to participate in this tender during currency of the suspension or ban period.

The Bidder should go through the website <http://eproc.rajasthan.gov.in> and the link "help for contractors", "information about DSC", "FAQs" and bidders manual kit" to know the process for

submitting the electronic bids at website. The complete bid document has been published on the website www.rsmm.com, eproc.rajasthan.gov.in and on sppp.raj.nic.in for the purpose of downloading.

The uploaded bid document shall be considered valid for participation in the bid process subject to submission of required cost of tender document, e-Tendering processing fee & EMD and the same shall be reached to the office of undersigned on or before the time specified for submission of techno-commercial part of tender.

The tender shall be pre-qualified on the basis of documents furnished/uploaded along with Techno-commercial bid in support of above. The decision of the company will be final and binding in this regard. The Company reserves its right to call for any additional information so as to check the eligibility of the tenderer.

In case tenderer is a Company registered under Companies Act, then turnover of the Company shall only be considered.

Any person participating in the tendering process shall be subject to code of integrity and disclose conflict of interest, as defined in rule 80 and should not have a conflict of interest in the tender as stated in rule 81 of Rajasthan Transparency in Public Procurement Rules, 2013 and the tender document. Appropriate actions against such bidder in accordance with section 11 and Chapter IV of the Act shall be taken, if it determined that a conflict of interest has flawed the integrity of tendering process. Tenderer found to have a conflict of interest shall be disqualified.

Tenderer(es) who have earlier been awarded contract by the company for any job & which they have abandoned or not accepted the work order awarded in their favour or contract has been suspended/ terminated by the company for breach of conditions or banned including those against whom any FIR has been lodged by the Company and is pending on the date of opening of techno-commercial bid shall not be eligible to participate in this tender/ during the currency of suspension/banned period.

Tenderer(es)(including any partner) who have been banned by the Company shall not be eligible to participate in this tender/ during the currency of banning period.

Offers furnished through any other mode shall not be considered. RSMML will not entertain any claim on account of postal delay/non-receipt. It also reserves the right to reject/cancel any or all tenders without assigning any reason whatsoever.

The price bid of only those bidders shall be opened who qualify in technical bid as per criteria laid in tender & only qualified bidders will be informed about price bid opening.

Section 1

Definition & Interpretation

1.1 Definition

In the contract (as hereinafter defined) the following words and expression shall have the meaning hereby assigned to them, except where the context otherwise requires.

- a) **“Contract”** shall mean an agreement between consultant and RSMML for performing the work as defined in the tender document.
 - (i) **“Clause” or “provision”** shall mean the clause and sub clauses of this tender document and/or agreement etc.
 - (ii) **“Contract”, “Contract Agreement”/“ Agreement”** shall mean the agreement between the company and the contractor for execution of work/s. The agreement document shall mean collectively Notice Inviting Tender, tender document, plans, and agreed variations (if any). Detailed Letter of Acceptance and other documents constituting the tender and acceptance thereof.
- b) **“Completion Period”** means the time permitted for completion of the entire Scope of Work and to the complete satisfaction of the RSMML.
- c) **“Contract document”** shall mean collectively tender document, designs, drawings, specifications, agreed variations, if any, and other document constituting the tender and acceptance thereof and shall be deemed to include any amendments, modifications to the contract document, or its constituent documents.
- d) **“Contract Rate”/“Schedule Rate /Rate of Remuneration”** means rate entered in figures and words in schedule/s by the Consultant and accepted by the RSMML as payable to the Consultant for preparation of the Mining Plan for the Kasnau-Matasukh Lignite Mine, Nagaur.
- e) **“Consultant (s)”** shall mean the person or persons, firm or company whose tender has been accepted by the RSMML and shall include the consultants legal representatives, his successors, executors, permitted assignees with whom the RSMML shall enter into contract agreement for providing Project Consultancy Services for successful completion of the Scientific/Technical studies as per scope of work.
- f) **“DLOA”** means the letter/ Fax of Acceptance issued by RSMML conveying its acceptance of bid to successful bidder.
- g) **“Effective Date”** means the date of Issuance of Detailed letter of Acceptance (DLOA) .
- h) **“Group General Manager (Lignite)”** shall mean the Group General Manager of SBU and PC-Lignite of RSMML or his successor in office.
- i) **“Managing Director”** shall mean the Managing Director of RSMML or his successor in the office as designated by the company.
- j) **“Mineral Concession Rules”** shall mean the rules made by the Central Gov. in exercise of the power conferred by section 13 of MMDR Act,1957(67 of 1957) These rules are called here MineralConsession Rules.
- k) **“Mines And Minerals (Development And Regulation) Act, 1957”** shall mean an Act to provide for the regulation of mines and the development of minerals under the control of the Union. Be it enacted by Parliament in the Eighth Year of the Republic of India.
- l) **“MoC”** shall mean Ministry of Coal agency in the administrative structure of the Central Government for Coal Mining.

- m) **“Officer-in-Charge”/ EIC** shall mean the individual so designated in writing by the RSMML to Consultant to be the RSMML’s authorised representative to make day to day decisions. For the purpose of this contract all communications addressed to the RSMML’s representative and delivered shall be deemed to have been received by the RSMML.
- n) **“Project Manager”** shall mean the individual so designated in writing by Consultant to RSMML to be the Consultant representative and authorised to make day to day decisions. For the purpose of this Contract all communications addressed and delivered to the Project Manager shall be deemed to have been received by Consultant.
- o) **“Project Site(s)”** means the area of Kasnau Matasukh Lignite mine area, adjoining areas and any other area required to be covered for execution of this assignment.
- p) **“RSMML”** means Rajasthan State Mines & Minerals Limited having its **registered office** at 89-90, Jan path, Lal Kothi, Jaipur (Rajasthan); **Corporate Office** at 4, Meera Marg, Udaipur (Rajasthan); and **SBU&PC-Lignite** office at Khanij Bhawan, Tilak Marg, C-Scheme, Jaipur (Rajasthan)
- q) **“Specification”** means and shall include the details, designs, drawings, statements of technical data equipment characteristics physical or chemical properties and all such particulars and documents mentioned in the tender document.
- r) **“Tender/Bid”** shall mean the tender / bid submitted by the tenderer /bidder for consideration & acceptance by the Company.
- s) **“Tenderer/Bidder”** shall mean the person, Firm/Company/Corporation/agency submitting a tender/bid against the Invitation for Tender/Bid and shall include his/its/their heirs, executors, administrators, legal representatives, successors etc.
- t) **“UNFC Code”** shall mean classification of a mineral deposit having the three dimensional system with the following three axes: Geological Assessment, Feasibility Assessment and Economic viability.
- u) **“Work”** shall mean all activities required for the completion of the Mining Plan, Mine Closure Plan and its approval from Ministry of Coal, GoI New Delhi with reference to the scope of work and the obligation to be undertaken by the consultant to this contract.

1.2 INTERPRETATIONS

Wherever it is mentioned that the contractor shall do or perform or cause to be done certain work/s or provide certain facilities or discharge certain obligation/s or make certain provision/s etc., it is expressly agreed and understood that each and every such work/s, facility, obligation/s or provisions etc. shall be made and/ or provided by the contractor to the satisfaction of the company at the cost and consequences of the contractor as the work is on turnkey basis.

- (i) Several clauses and documents forming the contract are to be taken in harmony. Should there be any discrepancy, inconsistency, error or omission in the contract or for any of the matter/s, the same shall be referred to in writing by the contractor to the Group General Manager (Lignite) of the company whose interpretation/s, decision in writing shall be conclusive, final and binding on the contractor.
- (ii) The works shown upon the drawing but not mentioned in the specifications or described in the scope of work without being shown on the drawings shall nevertheless be held to be included in the same manner as if they had been specifically shown upon the drawings and described in the scope of work.

- (iii) All headings and marginal notes to the various clauses of the contract are solely for the purpose of giving a concise indication and not a summary of the contents thereof and they shall never be deemed to be part thereof or be used in the interpretation or construction thereof, or the provisions of the contract.
- (iv) In the contract, unless otherwise stated specifically, the singular shall include the plural and vice versa, wherever the context so requires, the words interpreting person/s shall include incorporated companies, registered association, body of individuals or partnership firm.
- (v) Where any portion of the General Conditions of the contract is repugnant to or at variance with any provisions of the Special Conditions of the Contract, then, unless a different intention appears, the provisions of Special Conditions of the contract shall be deemed to override the provision of the General Conditions of the Contract and shall to the extent of such repugnancy or variations, prevail.
- (vi) Notwithstanding the sub-divisions/s of the various clauses of the contract into the separate parts/ sections, every part of such shall be deemed to be supplementary to and complementary of each and every other part and shall be read with and into the contract so far as it may be practicable to do so.
- (vii) General conditions of the contract shall be read in conjunction with the special conditions of contract, specification of work, drawings and any other documents forming part of this contract wherever the context so requires.
- (viii) The materials, designs and workmanship etc. shall mean the same as specified in the relevant Indian Standards and the job specifications contained herein and codes, referred to in the contract and the additional requirements, if any, shall also be satisfied by the contractor.
- (ix) No Director or official or employee of the company shall in any way be personally bound or liable for the acts or obligations of the company under the contract or answerable for any default or omissions in the observance or performance of any of the acts, matters or things which are herein contained.
- (x) No amendments to the contract shall be valid unless specifically made as an amendment in writing to the contractor and signed by the authorised representative of the parties, to the contract.
- (xi) The meaning of word enclose/submit of any documents shall generally means to upload the attested scanned copy of the same on e-procurement site unless clearly specified to send original document in physical form.

Section 2

2.1 Instructions to Tenderer

- (a) Tender is to be submitted online at <https://eproc.rajasthan.gov.in> in electronic form as prescribed in the tender form. Tender fees and processing fees will not be refunded in any case.
- (b) The Bidder should go through the website <https://eproc.rajasthan.gov.in> and the link "help for contractors", "information about DSC", "FAQs" and bidders manual kit" to know the process for submitting the electronic bids at website. The complete bid document has been published on the website <https://eproc.rajasthan.gov.in> for the purpose of downloading. The uploaded bid document shall be considered valid for participation in the bid process subject to submission of required cost of bid document and e-Tendering processing fee.
- (c) All communications/correspondences/documents including the bid document should be physically signed, stamped on each page before uploading and also signed digitally by the designated authorized representative of the bidder.
- (d) A scanned copy of EMD, e-Tendering processing fee and cost of tender document must be enclosed along with the Technical Bid proposal failing which the bid will be summarily rejected.
- (e) The DD towards the cost of tender document fees, Bid security and processing fees along with original affidavits as per format of tender document should be kept in a sealed envelope addressed to Group General Manager (Lignite), RSMML, Khanij Bhawan, Tilak Marg, C-Scheme, Jaipur. This envelope should be marked with NIT number & work, name and address of contractor, telephone number *etc.* is to be written on the top for clarity and to be submitted in the office of the Group General Manager (Lignite), RSMML, Khanij Bhawan, Tilak Marg, C-Scheme, Jaipur on or before the date and time as mentioned in the Notice Inviting Tender. The Company shall not be responsible for any postal delay. In case of non-receipt of same prior to the time of scheduled online submission of tender, the offer of the tenderer shall be rejected.
- (f) The tenderer in quoting his rate, shall for all purpose, whatsoever, be deemed to have himself independently obtained all relevant and necessary information for the purpose of preparing his tender. The correctness or completeness of the details, given in the tender documents is not guaranteed. The tenderer is required to satisfy him in all respect, before the submission of offer.
- (g) The tenderer shall be deemed to have examined the tender document, to have obtained his own information in all matters whatsoever that might affect the carrying out of the works at the schedules rates and to have satisfied himself to the sufficiency of his tender. Any error in description or quantity or omission in the Contract Document shall not vitiate the contract or release the Consultant from executing the work comprised in the contract according to specifications at the scheduled rates. The tenderer is deemed to know the scope, nature and magnitude of the works and requirement of materials, equipment, tools and labour involved, wage structures, conditions of service of

Company's staff/workmen doing similar and same type of work etc and as to what all works he has to complete in accordance with the contract documents irrespective of any defect, omissions or errors that may be found in the contract documents. The Consultant shall be deemed to have visited site and surroundings, to have satisfied himself to the working conditions at the site, availability of water, electric power, labour *etc.*, transportation facilities, probable sites for labour accommodation and store go-downs etc and all other factors involved in the execution of works.

- (h) All the provisions of Rajasthan Transparency in Public Procurement Act and rules made there under and modification to be issued by the competent authority from time to time will automatically be ipso-facto applicable

2.2 Tender Procedure

- (i) e-Tender portal <https://eproc.rajasthan.gov.in> shall be used for all procedure related to the bidding.
- (ii) The prospective Bidders should register themselves in the e-Tender Portal and submit the Bids electronically through the e-Tender portal.
- (iii) The Bidders are requested to download the e-Tender help manual and user manuals from the Portal for reference.
- (iv) It is mandatory for the Bidders to possess a valid Digital Signature Certificate to complete the e-Tender Bid process as per the provisions of Government of India IT Act.
- (v) The Technical Bid form and Price Bid form will be available in prescribed format for downloading. The registered Bidders can log into the e-Tender system and download the Bid Forms.
- (vi) The Bid forms should be filled and submitted using the Digital Signature Certificates. The supporting documents as required in support of tender should be scanned and uploaded in the e-Tender system.
- (vii) The Bid Form should not be changed or altered or tampered by the bidder. If the Bid form found tampered, the Bids will be summarily rejected.

2.3 Tender Document Fee

The Tender document fee as mentioned in the NIT shall be paid by way of DD in favour of RSMML payable at Jaipur.

(a) E-tendering processing charges

- i. For each and every Bid submitted, a non-refundable Processing charge of Rs. **500/-** should be paid by way of Demand Draft or Banker's Cheque drawn in favour of "MD RISL" payable at Jaipur. The payment by way of Demand Draft or Banker's Cheque should be deposited physically at office of Group General Manager (Lignite), RSMML, Khanij Bhawan, Tilak Marg, C-Scheme, Jaipur, Rajasthan-302005 on or before the date and time of submission of the Tender.
- ii. The payment particulars should be entered in the e-Tender Portal by the bidder while bidding.
- iii. If any of the information committed in the e-Tender Bid does not match with physically submitted payment, RSMML reserves the right to reject the bid summarily.

- iv. Even though the payment particulars are entered in the e-Tender portal, if
- v. the Bidder fails to submit the physical instrument prior to the scheduled date of submission of tender, their bid is liable for rejection.

2.4 ONE BID PER TENDERER

Each Tenderer shall submit only one Tender, either individually or as a partnership firm or a Private/Public limited Company or a co-operative society.

2.5 COST OF BIDDING

The Tenderer shall bear all costs associated with the preparation and submission of his offer, and the company will in no case be responsible or liable for those costs, under any conditions.

2.6 GENERAL INSTRUCTIONS FOR FILLING THE TENDER

- (i) All uploaded document shall be digitally signed by the tenderer or by a person holding power of attorney authorising him/her to sign on behalf of tenderer before submission of the tender.
- (ii) Tender in which any of the particulars and prescribed information is missing or incomplete in any respect and/or prescribed conditions are not fulfilled may be liable for rejection.
- (iii) Canvassing in connection with tenders is strictly prohibited for tenderers submitted by the tenderers, who resort to canvassing, will be liable for rejection.
- (iv) Tenderers, in their own interest are advised to read the tender document completely and carefully, to avoid submission of incomplete bid. Tender in which any of the particulars and prescribed information is missing or incomplete in any respect and/or prescribed conditions are not fulfilled are liable for rejection, at the sole discretion of the Company.
- (v) The Company takes no responsibility for delay, loss or non-receipt of required document sent through post/courier service. Offers through any other mode other than prescribed shall not be accepted.

2.7 CLARIFICATIONS OF CONTENTS OF TENDER DOCUMENT

- a. Should an intending tenderer require any clarification in connection with, or any point covered by, the tender documents, or as to any matter or thing to be done or not to be done by him in the event the contract for the work is awarded to him, he must submit a request for such clarification in writing so as to reach the Company at least seven days in advance of the last date fixed for submission of tender. Copies of any such clarifications furnished by the Company will be supplied to all other intending tenderer and such clarifications will constitute addenda/corrigenda to, and be read as part of the tender documents.
- b. The Company will not be bound by any oral clarification or interpretation of the tender documents or of any matter or thing connected with works to be executed in accordance with the tender documents, which may be made in by any of its employee, representatives or agent.
- c. Any neglect or failure on the part of the tenderer in obtaining necessary and reliable information upon the foregoing or any other matters affecting the contract shall not relieve him from any risks or liabilities or the entire responsibility from completion of the works at the scheduled rates and time in strict accordance with the contract documents.

2.8 ADDENDA/CORRIGENDA

- i. Addenda/Corrigenda to Notice Inviting Tender or to this tender document may be issued to clarify documents or to reflect modification in the specifications or terms & conditions or scope of work or for any other reasons.
- ii. Addenda/corrigenda to these tender documents, if issued by the company, shall form an integral part of this tender document.

Tenderer must upload the documents duly seal & signed in support of above required details and any declaration given by the tenderer without requisite supportive documents will not be considered. It may be noted that the bid shall be examined on the basis of documents uploaded, as per above required details, furnished along with it. A tenderer shall be fully responsible for consequences including rejection of his tender or cancellation of the

Contract if the required attested documents/attested copies of documents are not submitted/uploaded along with the techno-commercial bid or any information/document is found to be false/fabricated/misleading. The authorised signatory of the tenderer should put his signature along with its stamp on each page of the Techno-commercial bid and should also record the date.

2.11 PART-II Price Bid' (BOQ)

- (a) The 'Price Bid' shall be submitted online in the prescribed format. It is suggested to the tenderer to read carefully the instructions mentioned in the Proforma at Form-F, for quoting the price offer.
- (b) The rates are to be quoted in Rupees as per the price format.
- (c) While quoting the price under this part, the tenderer shall specifically confirm that the prices quoted are for the scope of work detailed in technical specification of the tender document.
- (d) The rates of remuneration to be quoted by the tenderer in Form-F of price bid as per BOQ should be including all taxes duties and levies except GST and shall be firm & fixed for entire contractual period. The rates to be submitted online in the prescribed format available at <https://eproc.rajasthan.gov.in> and not to be indicated here in Form-F of price bid .

2.12 EVALUATION OF PRICE BID

Part II of bid *i.e.* Price Bid of the short-listed bidder shall be evaluated for deciding the lowest tenderer (L-1) on the basis of the lowest quoted rate offered for the total contract work in form-E as per price Format.

2.13 Criteria for Deciding Lowest Tenderer:

The lowest quoted rate offered in Performa Form-F in the Online BOQ for the work shall be the criteria for deciding lowest tenderer as per price Format.

2.14 Correction of arithmetical errors

Provided that a Financial Bid is substantially responsive, the Procuring Entity will correct arithmetical errors during evaluation of Financial Bids on the following basis:

- i. If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected, unless in the opinion of the Procuring Entity there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price shall be corrected.
- ii. If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and
- iii. If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to (i) and (ii) above.

If the Bidder that submitted the lowest evaluated Bid does not accept the correction of errors, its Bid shall be disqualified and its Bid Security shall be forfeited or its Bid Securing Declaration shall be executed.

2.15 Price Negotiation

- i. Negotiations if required will be conducted with the lowest tenderer only. In case of non-satisfactory achievement of rates from lowest tenderer, RSMML may choose to make a written counter offer to the lowest tenderer and if this is not accepted, RSMML may decide to reject and re-invite fresh tenders or to make the same counter-offer first to the second lowest tenderer, then to the third lowest tenderer and so on in the order of initial bidding, and work order be awarded to the tenderer who accepts the counter offer.
- ii. In the case, when the quotations given by the tenderer during negotiations is higher than the original quotation of the tenderer then the tenderer will be bound by the lower rate originally quoted by the tenderer.
- iii. In case of negotiations, representative of the tenderer attending negotiations must possess written authority from the tenderer to the effect that he is competent to modify/amend the submitted tender deviations and rates offered by them.

2.16 DEADLINE FOR SUBMISSION OF BIDS

The Company may extend the deadline for submission of Bids by issuing an amendment, in which case all rights and obligations of the Company and of the Tenderers, which were previously subjected to the original deadline, will then be subjected to the new deadline.

2.17 LATE BIDS/ Delayed Bid

No bid will be accepted by the Company after the deadline prescribed in NIT due to any reason whatsoever.

2.18 PRE BID MEETING

RSMML proposes to hold a pre-bid meeting to clarify doubts and furnish replies to the questions/ observations raised by the tenderers on this tender document. The meeting will be held at SBU-PC (Lignite) Office, Khanij Bhawan, Tilak Marg, C- Scheme, Jaipur (Rajasthan) on ...04.2026 at 11:30 AM.

Tenderers are also advised to send their queries/clarifications in advance and addressed to the Group General Manager (Lignite), RSMML, Khanij Bhawan, Tilak Marg, C- Scheme, Jaipur, so as to reach him at least seven (7) days before the scheduled date of the pre bid meeting.

Tenderers are advised to participate in the pre bid meeting in their own interest, though it is not mandatory to do so. However the tenderers are requested to confirm their participation.

2.19 OPENING OF THE TENDER

The Techno-Commercial Bid of the offer will be opened as per NIT .

If the date fixed for opening of tenders happens to be a holiday for any reason, the tenders will be opened on the next working day at the same time.

2.20 EXCEPTIONS AND DEVIATION

Tenderers are advised to submit quotations based on the terms and conditions and specifications contained in the tender document and not to stipulate any deviations. Bids containing stipulations of deviation to the terms and conditions are liable to be ignored. In case it is absolutely unavoidable to deviate from tender conditions then the tenderers should mention the deviations at their risk of rejection only in the Form-E.

Deviations mentioned anywhere else in the bid shall be ignored without any consequences.

2.21 BID SECURITY

The tenderer shall furnish the bid security of 37,000/- in the form of demand draft or in Guarantee bond (refer Annexure-A) (having validity of three months) in favour of “RSMML” and drawn on any Nationalized / Scheduled bank at Jaipur and attach the same in original with the technical bid of the tenderer, failing which the bid is liable to be rejected.

The earnest money of the tenders whose bid is not found to be acceptable on the basis of pre-qualifying criteria and/or on evaluation of their techno-commercial bids (or disqualified bidder) will be refunded immediately after approval of such decision. The earnest money of the tenderer who are technically successful but not awarded the work shall be refunded after the acceptance of LOA/DLOA to the successful tenderer. The earnest money deposited by the successful tenderer will be appropriated towards a part of the Security deposit, but shall stand forfeited if the tenderer fails to furnish security deposit as per clause.

No interest shall be paid by the company on the earnest money so deposited by the tenderer.

The bid Security of a tenderer shall be forfeited in the following cases:-

- (a) If the tenderer withdraws or modifies the offer after submission of the tender.
- (b) If the tenderer does not submit the security deposit within one month of the date of work order/LOA issued in favour of tenderer.
- (c) If the tenderer does not execute the agreement, in the prescribed form within one month of the date of work order/LOA issued in favour of tenderer.
- (d) If it is established that the tenderer has submitted any wrong information/ forged documents along with the tender or thereafter.
- (e) If tenderer doesn't commence work within stipulated time as per tender.

2.22 VALIDITY

Tender submitted by tenderer shall remain valid for acceptance for a period 120 days, from the date of opening of the tender (Part I of the offer). An offer with a validity period of less than 120 days is liable to be rejected. The tenderer on its own shall not during the said period of 120 days or in extended period cancel and/or withdraw his tender nor shall he make any variation therein. In case of tenderer revoking, cancelling, modifying and/or withdrawing his bid during the validity of bid, the Bid security deposited by him along with tender shall stand forfeited, and tender will not be considered further evaluation.

In exceptional circumstances, prior to expiry of the original time limit, the Company may request the tenderer to extend period of validity for a specified additional period. The request and the tenderer's responses shall be made in writing. A tenderer if agreeing to the request will not be required or permitted to modify his bid.

2.23 EVALUTATION OF BIDS AND DETERMINATION OF RESPONSIVENESS

- i. Prior to the detailed evaluation of Bids, the Company will determine whether each Bid:
 - a) Meets the eligibility criteria.
 - b) Has been properly signed;
 - c) Is accompanied by the required securities; and

- d) Is substantially responsive to the requirements of the Bidding documents.
- ii. A substantially responsive Bid is one, which conforms to all the terms, conditions, and specification of the Biding documents without material deviation or reservations. A material deviation or reservation is one:
 - a) Which affects in any substantial way the scope, quality, or performance of the work; and/or
 - b) Which limits in any substantial way, inconsistent with the Bidding documents, the Company's right or the Bidder's obligation under the contract; and/or
 - c) Whose rectification/acceptance would affect unfairly the competitive position of the other Bidders presenting substantially responsive Bids.

2.24 EVALUATION OF TECHNO-COMMERCIAL BID

- i. The techno-commercial bids of substantially responsive tenderer's will be evaluated from all aspects. The RSMML reserves the right to assess the capability and competency of the tenderer based upon the information provided by the tenderer in the techno-commercial bid and the information that may other wise be available to and/or gathered by the RSMML. The decision of the RSMML as to which tenderer is capable & competent to carry out the work shall be final. The tenderer should, therefore, see that he has required level of technical, financial & managerial competence & experience before submitting the tender.
- ii. If a Bid is not substantially responsive, the Company at its sole discretion may reject it.
- iii. The tenderer shall be prepared to furnish clarification/information and attend meetings/discussion/ as required by the company from time to time.
- iv. Price Bid (part II) only of techno-commercially acceptable tenders shall only be opened.

2.25 PROCESS TO BE CONFIDENTIAL

- i. Information, relating to the examination, clarification, evaluation and comparison of Bids and recommendations for the award of a contract shall not be disclosed to the bidders or any other person not officially concerned with such process. Any effort by a bidder to influence the Company's processing of Bids or award decision may result in rejection of his bid.
- ii. The tenderer may note that indulgence in submitting unsolicited offers or submitting unsolicited correspondence after submission of bid is liable reject his offer and also to debar him from participating in RSMML tenders.

2.26 NOTIFICATION OF AWARD AND SIGNING OF AGREEMENT

- a) The tenderer, whose Bid has been accepted, will be notified of the award by the Company, through postal communication or through facsimile confirmed by registered letter/speed post. This letter (hereinafter and in Conditions of Contract called the "Letter of Acceptance / Detailed letter of Acceptance ")
- b) The notification of award will constitute the formation of Contract. The execution of agreement as per clauses below would be the formalisation of agreement that was commenced with the issuance of LOA/DLOA.

2.27 SIGNING OF THE CONTRACT AGREEMENT

The successful tenderer shall be required to execute an agreement on non-judicial stamp paper of appropriate value under Indian Stamp Act with the company within 30 days from the date of intimation regarding acceptance of tender, DLOA etc. The cost of execution of agreement including non-judicial stamp paper shall be borne by the successful tenderer/consultant.

The contract agreement shall consist of –

- (i) An agreement on non-judicial stamp paper of appropriate value,
- (ii) Tender document, along with the addenda/corrigendum, if any.
- (iii) Detailed letter of Acceptance .
- (iv) Agreed Variation, if any,
- (v) Any other document as mutually agreed.

2.28 RIGHTS OF COMPANY

The Company reserves the right –

- i) To reject any or all the tenders, in part or full, without assigning any reason thereto.
- ii) Not to accept the lowest tender or assign reasons for not accepting the lowest tender.
- iii) Not to carry out any part of work.
- iv) To reject the offer, if it is established that the tenderer has submitted any wrong / misleading information & forged document along with offer or thereafter.
- v) Any canvassing in connection with tenders is strictly prohibited and tenders submitted by the tenderers, who resort to canvassing, will be liable to rejection.

The company may exercise any of the above right at any time prior to the award of contract, without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the grounds for the RSMML's action.

2.29 REFUSAL / FAILURE

In the event the Tenderer, after the issue of communication of Acceptance of Tender by the Company (DLOA), fails/refuses to accept the award and/or commence execution of the work as herein before, the Tenderer shall be deemed to have abandoned the contract and such an act shall amount to and be construed as the Consultant's calculated and wilful breach of contract, and in such an event the Company shall have full right to claim damages/compensation thereof in addition to the forfeiture of Bid security /Security Deposit.

2.30 CODE OF INTEGRITY & CONFLICT OF INTEREST

Any person participating in the tendering process shall be subject to code of integrity and shall disclose conflict of interest, as defined in rule 80 and should not have a conflict of interest in the tender as stated in rule 81 of Rajasthan Transparency in Public Procurement Rules, 2013. Appropriate actions against such bidder in accordance with section 11 and Chapter IV of the Act shall be taken, if it determined that a conflict of interest has flawed the integrity of tendering process. Tenderer found to have a conflict of interest shall be disqualified. Bidder shall be required to provide a declaration under Section 7 of Rajasthan Transparency in Public Procurement Act, 2012 in support of their qualification, as per annexure given in the tender document.

2.31 APPEALS

Subject to section 40, of Rajasthan Transparency in Public procurement Rules 2013 , if any bidder or prospective bidder is aggrieved that any decision, action or omission of the procuring entity is in contravention to the provision of this act or the rules or

guidelines issued there under , he may file an appeal to designated First and Second Appellate Authority within a period of ten days from the date of such decision or action, omission as the case may be clearly giving the specific ground on which he feels aggrieved on the form no. 1 (see rule 83) –Memorandum of Appeal under the Rajasthan Transparency in public procurement Act -2012 with prescribed fees.

2.32 DECLARATIONS TO BE MADE & SUBMITTED BY THE BIDDER

The following specific declarations/ undertakings/ affidavits are required to be made and submitted by the tenderer/bidder in the respective formats which are described at the end in this document as **Forms-A to H**. These are to be provided in appropriate manner on letter heads/ appropriate stamp paper as mentioned in respective formats. The affidavits/declarations on stamp/ letter heads are required to be submitted in original and scan copy of same should be uploaded online in the bid.

- i. Form A : Letter for submission of tender
- ii. Form B : General information about the tenderer
- iii. Form-C : Details of experience (if any)
- iv. Form D : Bank Details
- v. Form E : Exceptions & Deviations
- vi. Form F : Price Offer (**Blank**). The Rate should be quoted through BOQ and submitted online as per e-tendering process.
- vii. Form G : Declaration for Inspection of Site
- viii. Form H : Affidavit in respect of litigation/ suspension etc.
- ix. Annexure-D: (Annexure-a) under the Rajasthan Transparency in Public Procurement Rules, 2013. (Annexure-b) Declaration by the Bidder regarding Qualifications. (Annexure-c) Grievance Redressal during Procurement Process Form No.1 (see rule 83). Annexure-d: Additional Conditions of Contract.
- x. Documents in support of Pre qualifying criteria.
- xi. Copies of instruments (DD/BC/BG/E-payment) in support of Tender Fee, Processing Fee & EMD etc which are deposited in original.

2.33 INTERFERENCE WITH PROCUREMENT PROCESS

In case the bidder

- i) Withdraws from the procurement process after opening of financial bids;
- ii) Withdraws from the procurement process after being declared the successful bidder
- iii) Fails to enter procurement contract after being declared the successful bidder;
- iv) Fails to provide performance security or any other document or security required in terms of the bidder documents after being declared the successful bidder, without valid ground, Shall, in addition to the recourse available in the bidding documents or the contract be punished with fine which may extend to fifty lakh rupees or ten percent of the assessed value of procurement, whichever is less.

SECTION 3

General Conditions of Contract

3.1 Security Deposit

- (i) The successful bidder shall furnish a Security Deposit equal to 10% of the total contract value through Demand Draft / Bank Guarantee in favour of RSMML, Jaipur, within 30 days of the issuance of such communication of acceptance of tender/ Detailed letter of Acceptance (DLOA), for due fulfillment of all or any of the terms & conditions of the contract in any of the following manners mentioned from 3.1(ii) to 3.1(v).
- (ii) Bank Guarantee (B.G.) (Annexure–B) amounting to 10% of the value of contract in favour of the RSMML Jaipur. The Bank Guarantee shall be provided only in the approved format of the company from a schedule bank having its branch at Jaipur on non–judicial stamp paper of 0.25% of BG value subject to maximum Rs. 25,000/- or on appropriate value of stamp paper as per prevailing stamp act on the date of issue of BG. Bank Guarantee shall be valid for the entire period of the contract and extended period, if any plus six months. The entire Security Deposit shall be refunded after six months of the expiry of contract, provided always that the Contractor has been first paid all the bills including his final bill subject to deductions as are permissible under these terms and all other dues to the Company arising out of this contract, if any, have been fully met by the Contractor and the Contractor has rendered “No claim and No Dues Certificate” to the Company.
- (iii) Fixed Deposit Receipt (FDR) equivalent to 10% of Total contract value issued from a schedule bank having its Branch office at Jaipur. FDR shall be in the name of RSMML on account of Successful bidder and discharged by him in advance. The accepting authority shall ensure, before accepting the Fixed Deposit Receipt, that the successful bidder furnishes an undertaking from the bank to make payment/premature payment of the Fixed Deposit Receipt on demand to the Company without requirement of consent of the successful bidder. In the event of forfeiture of the security deposit, the Fixed Deposit shall be forfeited along with interest earned on such Fixed Deposit without protesting by the contractor/him.
- (iv) The successful bidder shall have the right to exercise his option, at the time of signing of the agreement, for progressive deduction of security deposit @ 10% from his running / final bills.
- (v) The Security Deposit shall be liable to be forfeited wholly or partly at the sole discretion of the Company, should the Contractor either fail to fulfill the contractual obligations or fail to settle in full, his dues to the Company. In case of premature termination of the contract, the Security Deposit will be forfeited and the Company will be at liberty to recover the loss suffered by it from the Contractor.
- (vi) The Company may deduct from the Security Deposit any sum due and any other sum that may be fixed up by the Company as being the amount of loss or losses or damages suffered by it due to delay in performance and/or non-performance and/or partial performance of any of the terms of the contract.

- (vii) All compensation or other sums of money payable by the Contractor to the Company or recoveries to be made under the terms of this contract may be deducted from any sums which may be due to the Contractor from the Company on any account and in the event of the such amount being insufficient the Contractor shall within ten days of such shortfall make good in cash, failing which the balance amount shall be recovered by way of invoking the bank guarantee furnished as security.
- (viii) In the event of bank guarantee amount being insufficient, then the balance recoverable amount shall be deducted from any sum, then due or which at any time thereafter may become due to the contractor. The Contractor shall pay to the company on demand any balance remaining due.
- (ix) In case the Bank Guarantee is invoked for any reason/s, the contractor is required to furnish a fresh Bank Guarantee in the same format for the same amount and for the same period as the original Bank Guarantee within a period of 30 days from the date of invoking of original Bank Guarantee.
- (x) In the event of security amount at any time during the currency of the contract falling short of the specified amount, the Contractor shall forth with make good the deficit on demand, so that the total amounts of Security Deposit will not at any time be less than the amount so specified. The Company may recover the same by way of additional deductions from bills.
- (xi) No interest is payable on S.D. amount.
- (xii) In case of enhancement of quantum of work, due to any reason, the contractor shall furnish additional security amount. This security will be progressively recovered from the payment due to the contractor.
- (xiii) If the contractor or their employee cause any damage or destroy any property belongs to the company & others during execution of contract the same shall be made good by the contractor at his own expenses and in default thereof, the engineer in-charge may cause the same to be made by other agencies and recover expenses from the contractor.

3.2 ADDITIONAL PERFORMANCE SECURITY -

In addition to Performance Security as specified in rule 75-A of RTPP Rules, an Additional Performance Security shall also be taken from the successful bidder in case of unbalanced bid. The Additional Performance Security shall be equal to fifty percent of Unbalanced Bid Amount. The Additional Performance Security shall be deposited in lump sum by the successful bidder before execution of Agreement. The Additional Performance Security shall be deposited through Demand Draft, Banker's Cheque, Government Securities or Bank Guarantee.

Explanation: For the purpose of this rule,-

- a) Unbalanced Bid means any bid below more than fifteen percent of Estimated Bid Value.
- b) Estimated Bid Value means estimated value of the work as mentioned in bidding documents.
- c) Unbalanced Bid Amount means positive difference of eighty five percent of Estimated Bid Value minus Bid Amount Quoted by the bidder.
- d) The Additional Performance Security shall be refunded to the contractor after

satisfactory completion of the entire work. The Additional Performance Security shall be forfeited by the Procuring Entity when work is not completed within stipulated period by the contractor.

3.3 Taxes:

The consultant shall be responsible for the deposition of any and all contributions, duties, levies and taxes including service tax, as applicable etc. with the concerned authorities of the Central or State Government authorities, applicable for execution of the works under the contract.

All taxes/duties/levies as applicable should be taken into consideration while making the offer. Ignorance in it shall not qualify for any additional payment. RSMML will reimburse/recover at actual any taxes/duties which are imposed/increased /withdrawn /decreased after the date of submission of offer & are directly applicable to this contract & payable by the consultant/recovered by RSMML & determined on the basis of bills raised by him upon the company, if applicable, subject to the furnishing of documentary proof.

3.4 Waiver and Liability to pay Compensation:

In any case in which any of the powers conferred upon the Company shall have become exercisable and the same have not been exercised, the non exercise thereof shall not constitute a waiver of any of the conditions hereof and such powers shall be exercisable in the event of any further case of default be the Consultant, the consultant shall be liable to pay compensation amount to the Company, the consultant shall be liable to pay compensation amount to the extent of the whole of his Security Deposit and the liability of the Consultant for past and future compensation shall remain unaffected.

3.5 Company not Liable to pay Compensation:

The Consultant shall have no claim against the Company for any business loss, idle charges, compensation upon failure, delay, omission etc. on the part of the Company to carry out any or all the provisions of the contract for any reason whatsoever. The Company's decision in the matter shall be final and binding on the Consultant.

3.6 No Claim if work is Abandoned or Postponed:

The Consultant will have no claim, whatsoever, against the Company, if the work or any part thereof covered by the contract is postponed to any later date and/ or withdrawn in part in the overall interest of the Company or for security or for any other reason/s. The Company's decision in this regard shall be final and binding on the Consultant.

3.7 No Compensation for Alteration in or Restriction of work:

If any time after the commencement of the work the company shall for any reason or under instructions of Directorate General of Mines Safety in case of mining contracts or any other statutory authority for mining and other contracts, whatsoever required not to do the whole work or part thereof as specified in the schedule of work to be carried out, the Engineer-In-Charge shall give notice in writing of the fact to the consultant, who shall have no claim to any payment or compensation whatsoever on any account or profit or compensation or advantage/s which he might have derived from the execution of the work in full, but which he did not derive in consequences of the full amount of the work not having been carried out, nor shall have any claim or compensation by reason of any alternations having been made in the original specification, drawings, designs and instructions which shall involve any curtailment of the work as originally contemplated.

3.8 Insurance:

Under the insurance scheme the consultant shall be required to get comprehensive insurance plan, Universal Health Insurance policy for all the persons engaged in work to meet the

liability arising out of workman compensation Act. Copy of insurance policy must be submitted to RSMML for record. The management on this account shall reimburse no amount.

3.9 Discrepancies between Instructions:

Should any discrepancy occur between the various instructions furnished to the Consultant, his agents or staff or any doubt arising as to the meaning of any instructions or should there be any misunderstanding between the Consultant's staff, the Consultant shall refer the matter immediately in writing to the Engineer-in-Charge whose decision thereon shall be final and conclusive and no claim for losses alleged to have been caused by such discrepancies shall in any case be admissible.

3.10 Company may do part of work:

Upon failure of the consultant which includes sub-consultant/s, if any, to comply with any instructions given in accordance with the provision of the contract, the Company retains the right instead of assuming charge of entire work, or also engages another Consultant to carry out the work at the risk and cost of the Consultant. In such cases, the Company shall deduct from the amount due or which otherwise might become due to the Consultant, the cost of such work and materials etc, plus 15% additional charges thereon to cover all departmental charges/ expenses and the Consultant shall be bound by such decision of the Company.

3.11 Power to order Suspension of work:

The Company may, from time to time, by direction in writing and without in any way invalidating the contract, order the consultant to suspend the work or any part thereof at any time and for such times and for such reasons as he may consider necessary. After such directions to suspend the work, or any part thereof, has been given the Consultant shall not proceed with the work or part thereof directed to be suspended until he receives a written order from the Company to so proceed. In the event of suspension exceeding three days the Company may under the provision of the contract extend the time for completion of work or part thereof by such time as it may find reasonable. The decision of the Company in the matter shall be final and binding on the Consultant. The Consultant shall not be entitled for any extra payment in case of such suspension. The Consultant without prior knowledge and approval of the Company thereof shall not suspend the work of any other part. If the Consultant is compelled to suspend the work or any part thereof he should report to the Engineer-in-Charge, furnish the reasons, necessitating such granted to the consultant if he proposes to suspend the work or any part thereof, on his own. In case such suspension is necessitated for reasons beyond control and period of suspension becomes more than 3 month at a stretch then Company may consider making some adhoc/ advance payment against the work done. The quantum and more of payment shall be mutually decided. It will be however, sole discretion of company & will not be available as right of the consultant.

3.12 Change in Constitution:

The Consultant shall inform the Company before any change is made in the constitution of the Firm/ Company or induction or retirement of any of the partners/ directors at the earliest.

3.13 Compliance in respect of various Acts:

The consultant shall at his own cost, observe, perform and comply with the provisions of the Acts applicable during the execution of the Contract, and Rules/Bye-laws as applicable to this work .Non-compliance of the provisions/ stipulations of the those Acts and rules made there will render the Consultant liable to payment of necessary compensation/penalty, as deemed fit by the Company.

3.14 Compensation and Liability:

- a) The consultant at his cost shall affect insurance for all the consultant's employees and persons engaged in the performance of the contract.
- b) In case of an accident in respect of which Workman's Compensation Act or Motor Vehicles Act, Fatal Accident Act or Mines Act etc. applies it shall be lawful for the Engineer-in-Charge to retain money out of due and payable amount to the consultant, such sum or sums of money as may in the opinion of the Engineer-in-Charge shall be final in regard to all such matters arising under this clause and the Consultant shall be bound by such decision of the Engineer-in-Charge.
- c) The Company shall not be liable for or in respect of any damages or compensation payable as per law in respect of or in consequence of any accident or injury to any workman or other person in the employment of the consultant or any of his sub-consultant or third party etc and the Consultant shall indemnify and keep indemnified the Company against all such injury, damages and compensation and against all claims, demands, proceedings, costs, charges and expenses, whatsoever in respect of or in relation thereto.

3.15 Force Majeure:

Neither the Consultant nor the RSMM shall be considered to be in default in the performance of their respective obligations under this contract if such performance is prevented or delayed because of the conditions constituting force Majeure which shall include but not limited to notice/s from the Directorate of Mines Safety , other Statutory Authority, Civil Commotion, Fire accidents, epidemics, War, acts of God or because of any law, order, proclamation or ordinance of any Government or, cause beyond reasonable control of the party affected, provided notice of such cause is given in writing by the party affected within 14 days of the happening of the event. In case it is not possible to serve the said notice within the said period of 14 days then within the shortest possible period. As soon as the cause of force Majeure has been removed, the party whose ability to perform its obligation has been affected shall notify the other of such cessation. Should one or both the parties be prevented from fulfilling their contractual obligations by state of force Majeure lasting for a continuous period of three months both the parties shall consult each other and decide about the future course of action regarding the contract.

3.16 Service of Notice on Consultant:

Any notice hereunder may be served on the Consultant or his/its duty authorized representative at the work site or may be served by registered mail directly to the address furnished by the Consultant. Proof of issue of any such notices shall be conclusive of the fact that the Consultant having been duly informed of all contents therein. The consultant shall furnish to the Company, the name, designation and addresses of his/its authorized representative at the work site.

3.17 Termination:

If the Consultant fails to execute the work or any part thereof with such diligence as will ensure its completion within the time specified in the contract, or extension thereof, or fails to complete the said work within such time or fails to perform any of his obligations under the contract or in any manner commits a breach of any of the provisions of the contract, it shall be open to the Company in its option, by written notice to the consultant: -

- (a) To determine the contract; in which event the contract shall stand terminated and shall cease to be in force and effect on and from the date notified by the company in this behalf, whereupon the consultant shall stop forthwith all or any of the contract work, then in progress and the Company may on its part, may take over the work remaining incomplete by the Consultant and the consultant and his sureties if any, shall be liable to the company for any excess cost occasioned by such take over and completion by the Company or by appointing any other agency over and above the rates of remuneration payable under the contract.
- (b) Without determining the contract, to take over the work of the Consultant or any part thereof and complete the same through any other agency at the risk and cost of the consultant and the contract, and his sureties shall be liable to the company for any excess cost/ additional cost occasioned by such work having been so taken over and completed by the Company and/or through any other agency over and above the remuneration payable under the contract.

Before determining the contract, as aforesaid, and provided that, in the judgment of the company, the default or defaults committed by the consultant is or are curable or may be cured by the Consultant if any opportunity is given to him to do so, the Company may, by notice, in writing, call upon the Consultant to cure the default within such time as may be specified in the notice.

In the event of the Company proceeding in the manner herein above prescribed:-

1. The whole of the Security Deposit furnished by the Consultant or retained by the Company shall be liable to be forfeited, without prejudice to the right of the Company to recover from the Consultant, the excess cost referred to aforesaid. The Company shall also have the right to take possession of the sites for completing the work or any part thereof, with any or all such materials, equipments, machinery tools and tackles belonging to the consultant, as may be deployed / used for the work.
2. The money that may have become due to the Consultant on account of work executed by him/its already shall not be payable to him/its until after the expiry of six calendar months reckoned from the date of determination of contract or from the taking over of the work or part thereof by the company as the case may be, during which period the responsibility for fully workmanship in respect of such work shall, under the contract rest exclusively with the Consultant and shall be subject to deduction of all amounts due from the Company to the Consultant, whether under the terms of the contract or otherwise, authorized or required to be recovered or retained by the Company.

The Company shall also have the right to proceed in the manner prescribed in sub-clauses above, in the event of the consultant abandoning the execution of the contract work for a continuous period of one month, or becoming bankrupt or insolvent, or compounding with his creditors or assignees the contract in favour of his creditors or any other person or persons, or being a firm or a corporation goes, into voluntary liquidation, provided that in the said event, it shall not be necessary for the Company to give any prior notice to the Consultant.

Termination of the contract as aforesaid shall not prejudice or affect the rights of the Company which may have accrued upto the date of such termination.

3.18 Dispute, Jurisdiction:

- a) The place of the contract shall be Jaipur (Rajasthan). In cases of any differences, the same shall be resolved by mutual discussions and agreement. However the decision of the GGM (Lignite), Jaipur of the company shall be final and binding.
- b) No courts other than the courts located at Jaipur- Rajasthan shall have jurisdiction over any matter concerning any aspect of the work under this tender.
- c) The consultant shall not stop or abandon the work due to and during the pendency of such disputes or differences.

SECTION-4

Scope of Work & Special Conditions of Contract (SCC)

4.01 Applicability:

These terms and conditions are in addition to the General terms and conditions specified in earlier Sections of this tender document. These special terms and conditions as detailed in this section in the following clauses shall prevail upon the General terms & conditions, should there be any discrepancy or conflict or contradiction between the two.

4.02 Introduction:

The Company is involved in the mining, beneficiation, processing and marketing of various minerals like Rock Phosphate, Limestone, Gypsum, and Lignite etc.

4.03 Location and Accessibility of Site:

The Kasnau-Matasukh Lignite project, proposed for Preparation of Revised Mining Plan & Mine Closure Plan (1.0 MTPA), is located at a distance of about 36 Km. East of Nagaur Town, Tehsil Jayal, District Nagaur, Rajasthan. The area is located between Latitude 27⁰ 03' 47.0782" to 27⁰ 06' 38.1079" and Longitude 74⁰ 03' 13.3873" to 74⁰ 04' 42.6858" and can be located on Survey of India Topo Sheet numbers 45 I/4.

Kasnau-Matasukh Lignite Mine is connected with Jayal tehsil head quarter through Farrod village. A Metalled Road connects Farrod village to Kasnau-Matasukh Lignite Mine for a distance of 6.5 km. The Farrod village in turn connects the Jayal tehsil head quarter through Nagaur-Didwana State Highway Road a distance of 7 km. The District headquarter-Nagaur is connected from Mines by a hard top road for a distance of about 40 Kms. Nagaur is situated more or less equidistance from Jodhpur & Bikaner at a distance of 160 & 165 Kms respectively on Jodhpur-Bikaner state highway. The nearest railway station Mundwa, is about 25 Kms. away on Merta road, while Merta Road Junction is 35 Kms from mines. Jodhpur is the nearest Airport 165 km towards west of Nagaur town.

4.04 SCOPE OF WORK:

Scope of Work for preparation of Mine Plan & Mine Closure Plan (1.0 MTPA) in respect of Kasnau–Matasukh Lignite Mines(1063.35 hectare), Tehsil-Jayal District-Nagaur (Raj.) of 'Rajasthan State Mines & Minerals Ltd.' by Open Cast Mining method, expert review by MPPA and getting its approval from Ministry of Coal (MoC), Govt. of India & related terms & conditions.

- i. Agency is to prepare Mine Plan & Mine Closure Plan (MP& MCP) of Kasnau–Matasukh Lignite Mines as per guidelines issued by Ministry of Coal, Govt. of India dated 31st January 2025 followed by the terms of MM(DR) Act, Mines Act and Mineral Concession Rules (MCR-2020), CMR-2017, prevailing other guidelines and any other subsequent guideline/amendment therein.
- ii. Formulation of Revised Mining Plan & Mine Closure Plan shall be done by Qualified Person (QP)/ Accredited Mining Plan Preparing Agency (MPPA) in accordance with the recognition granted to the consultant *i.e.* QP/MPPA for preparation of mining plan u/s 22B of Mineral Concessions (Amendment) Rules, 2020.
- iii. For the purpose of preparation of Revised Mining Plan & Mine Closure Plan through a QP or MPPA, project proponent shall share a temporary login with the consultant *i.e.* QP/MPPA. This temporary login shall be valid till the preparation and approval of

mining plan only.

- iv. The consultant shall submit draft Revised Mining Plan & Mine Closure Plan prepared by a QP or MPPA, alongwith plans, sections & all annexures to project proponent & get it approved.
- v. Agency is to upload the material through the provided temporary login and submit it to the project proponent on the Single Window Clearance System (SWCS) of MoC/ Coal Controller Organization (CCO), New Delhi (<https://swcs.coal.gov.in>), as required under guidelines and forward the same to proponent for vetting/ observation. All the required plates and annexures are required to be prepared as per the guidelines of MP & MCP in SWCS Portal.
- vi. Agency to forward the MP&MCP through SWCS to Expert Review Agency (ERA) *i.e.* MPPA (at their own cost) & subsequently to the Internal Committee of CCO, MoC after receiving vetting from proponent.
- vii. Agency to comply the observation of the Expert Review Agency (ERA) and accordingly updation in MP & MCP will be done in the MP&MCP through SWCS.
- viii. After certification by ERA, agency to forward the MP&MCP to MoC/CCO after incorporating relevant company board approvals & after remitting non-refundable fee into Bharatkosh as processing Fee. (Payment to Bharatkosh done by project proponent).
- ix. Agency to make presentation for scrutiny the MP&MCP before in statutory agencies (MoC/ CCO etc) and attend all scheduled meetings, physical verification leading to obtaining the clearance.
- x. Agency to provide all clarifications regarding the MP&MCP, if required by client or Statutory Agencies/committee (MoC/ CCO *etc.*).
- xi. Agency to share all documents to proponent related to preparation of MP & MCP.
- xii. Agency to obtain approval of Mining Plan & Mine Closure Plan from MoC, Govt. of India.

4.05 The tenderer should fulfill following pre-qualifying criteria:

1. The tenderer should have minimum turnover of Rs. 9.25 Lac in any one of the immediate three preceding financial years *i.e.* 2023-24, 2024-25 and 2025-26.
2. The tenderer/ bidder must be Qualified Person (QP)/ Accredited Mining Plan Preparing Agency (MPPA) in accordance with the recognition granted to consultant *i.e.* for preparation of mining plan u/s 22B of Mineral Concessions (Amendment) Rules, 2020.
3. The tenderer/bidder must have experience of preparation, submission, expert/ peer review & approval of Mining Plan of at least one (1) Mechanized opencast Coal/ Lignite mines from Ministry of Coal, Govt. of India though online submission mode.

4.06 Period of Contract:

- a) In totality the period of contract shall be tentatively Six (6) months from the date of issuance of Detailed Letter of Acceptance (DLOA). Any delay on account of late communication from Ministry of Coal, GoI may be considered by the Company on the request of the Consultant and prescribed time periods mentioned above shall be modified.

- b) In case of failure to commence the work within the stipulated period, the company shall have absolute discretion to withdraw the Detailed letter of Acceptance (DLOA) & forfeit the Bid Security Money & / or Security Deposit & also to award the contract to any other party without prejudice to rights of the company to claim compensation & other costs from the consultant.

The requisite number of Reports & Documents as prepared by the Consultant shall be provided for submission at various Government Departments at different stages, for which, no additional remuneration shall be paid.

4.08 Mobilization & Commencement of Work:

- a) In the event of the award of the contract, the consultant shall have to commence the work immediately within 15 days from the date of issue of Detailed Letter of Acceptance (DLOA).
- b) In exceptional circumstances & at its sole discretion, the company may extend the commencement period if so requested by the consultant. In case of failure to commence the work within the stipulated period, the company shall have absolute discretion to

withdraw the detailed letter of Acceptance and forfeit the Bid Security Deposit (EMD) &/ or security deposit (SD).

4.09 Compensation for Delay in Commencement & Completion of work:

a) For Delay in Commencement

Compensation @ 0.5% of the total contract value on weekly basis with maximum up to 5% of the contract value may be levied in case; Consultant fails to commence the work within 15 days period, of issuance of LOA/DLOA. If the delay is on the account of consultant is more than 8 weeks then the company may withdraw the Detailed letter of Acceptance and forfeit the Bid Security Money & /or security deposit (SD) also.

b) For Delay in Completion of work

In case of failure to complete the work up to S.No. 1 to 4 of clause 4.06 as per given tentative time schedule from the date of DLOA in totality then the company shall have absolute discretion to levy predetermined compensation @ 1% of the total contract value on weekly basis with maximum up to 10% of the contract value. If the delay in completion of work is on the account of consultant is more than 8 weeks then it shall be sole discretion of company to forfeit the security deposit (SD).

c) In case consultant fail to complete the works mentioned at Clause 4.06 (5) & Clause 4.06 (6), then the consultant shall be liable for the forfeiture of SD amount and payment shall be made only upto the stage of work completed as per the Clause 4.06.

4.10 Right to review Performance:

- i) The Company reserves its rights to review and assess performance of work at any time during the contract period. In case of poor or unsatisfactory performance and/or breach of any terms and conditions of the contract, the company in its absolute right and discretion may take appropriate action including termination of the contract.
- ii) The company shall have absolute right to determine and ascertain the damages or losses suffered by it due to poor performance or breach of the terms and recover the costs thereof from the consultant from the security deposit or any sum due to the consultant from the company. The Company shall also have absolute right to get the work done from any other agency at the risk and cost of the consultant, in case, the consultant fails to perform the work.

4.11 Consultant's Remuneration:

- i) The consultant, in view of the services rendered for the work under scope of work and in view of terms and conditions mentioned herein shall be entitled to get remuneration. Accepted rate shall be considered as the rate of remuneration to the consultant.
- ii) The schedule of rates or contract rate or rate of remuneration shall include an indemnity to the company which the consultant hereby gives against all actions, proceedings, claims, damages, costs & expenses arising from the incorporation in or use on the works of any such articles/processes or materials, equipment or machinery to be brought to the site for use on work, shall borne by the consultant.
- iii) Without in any way limiting the provisions of the proceeding ,sub clause, the schedule of rates or rate of remuneration shall be deemed to include & cover the cost of all inputs for the works or otherwise, also all rents,& other payments for the works, all equipments, temporary works, materials, labour, insurance, fuel, stores & appliances to be supplied /deployed by the consultant & all other matters in connection with each item in the schedule of work & the

execution of the work or any portion thereof finished complete in every respect & maintained as shown or described in the contract documents.

- iv) The rate of remuneration shall be deemed to include & cover the risk of all possibilities of delay & interference with the consultant's conduct of which occur from any cause including orders of the company in the exercise of his/its powers & on account of extension of time granted due to various reasons & for all other possible or probable cause of delay/s in execution of this work by the consultant. The consultant shall not be entitled to raise any claims &/ or dispute on account of any rise in the price of stationery, equipment/s, spares, statutory or otherwise on any ground or reason or account of whatsoever.

4.12 Terms of Payment (Billing):

- i. Remuneration is to be paid by the company to the consultant as per schedule given at clause 4.06 after submission of requisite security deposit.
- ii. For payment purpose the consultant shall raise the bills for the part completed of work, to receive its remuneration from the office of the GGM (Lignite), Khanij Bhawan, Jaipur & the bills shall be duly verified by the concerned Officer In-charge in respect of the work that it is being/has been carried out as per terms & conditions of the contract.
- iii. The rate as accepted by the company & governed as per the LOA/DLOA alone shall be considered for billing purpose. The company shall be deducting applicable taxes as prevailing, from the bills of the consultant.
- iv. Payment of the bills shall ordinarily be released within 15(fifteen) days from the date of receipt of bill at SBU-PC (Lignite) office Jaipur.

4.13 Escalation/De-Escalation:

The consultancy remuneration rate will remain firm & fixed during contract period; and no escalation will be considered on account of any changes by Ministry of Coal, Government of India, in process / methodology for approval of revised Mining Plan & Mine Closure Plan through any notification, office memorandum, guidelines, circulars etc; after submission of offers.

4.14 TAXES:

The contractor shall be responsible for the deposition of any and all contributions, duties, levies and taxes etc. with the concerned authorities of the Central or State Government authorities, applicable for execution of the works under the contract.

All taxes/duties/levies as applicable should be taken into consideration while making the offer. Ignorance in it shall not qualify for any additional payment.

RSMML will reimburse/recover at actual any taxes/duties which are imposed/ increased / withdrawn /decreased after the date of submission of offer & are directly applicable to this contract & payable by the contractor/ recovered by RSMML & determined on the basis of bills raised by him upon the company, if applicable, subject to the furnishing of documentary proof.

(i) GOODS AND SERVICE TAX:

- a) The rate quoted by the bidder will be exclusive of Goods & Service Tax (GST). However, the rates will be inclusive of any other levies and duties, as applicable on this contract (up to last date of submission of bid).
- b) The rates quoted shall be on firm price basis during the pendency of the contract period

- and the contractor shall not be eligible for any escalation in rates on whatsoever ground.
- c) The provision of GST should be followed by the Contractor as applicable and will be reimbursed on the submission of challan, failing which RSMML is free to deduct/recover/ retain such amount from the bills of contractor or any other amount due to him/ or from Security deposit, as the case may be.
 - d) Timely deposition of GST and filing of requisite tax returns of relevant tax period would be sole responsibility of the contractor. The contractor will also ensure that necessary credit on this account is available to RSMML in the next month. In case of any discrepancy where credit is not available to RSMML then company is free to deduct/recover/retain such amount from the bills of contractor or any other amount due to him/ or from Security deposit, as the case may be.
 - e) In case of reversal of Input Tax Credit (ITC) and imposition of penalty on account of payment of GST and default in filing of returns towards the payment for the work, contractor is liable to pay all such dues to the company, failing which RSMML is free to deduct/recover/ retain such amount from the bills of contractor or any other amount due to him/ or from Security deposit, as the case may be.

4.15 Application for Completion Certificate:

- (a) When the Consultant fulfils all his / its obligations under the contract to the satisfaction of Engineer-In-Charge and subject to terms & conditions of the contract he/it shall be eligible to apply for completion certificate. The application along with following documents and any other document/ information etc. as required by the Engineer-In-Charge for his satisfaction, are required to be submitted to the Engineer-In-Charge.
 - (i) Consultant shall submit the No claim in favour of company that No claim has been due towards the company and he will not claim any dues after the closure of the contract.
 - (ii) Indemnification Bond of appropriate value on Non-Judicial stamp paper.
 - (iii) A certificate to the effect that no outstanding claims/ payments are due to the persons employed by the consultant or his sub-consultant.
 - (iv) Certificate of satisfactory execution of the contract from the Engineer-In-Charge.
- (b) The Engineer-In-Charge shall formally issue completion certificate within 60 (Sixty) days on receiving application from the Consultant, after verifying from the completion documents and satisfying himself that the work has been completed in accordance with all the provisions of this contract and as set out in the drawings/ specifications etc and instructions issued to the Consultant by the Company or any statutory authority from time to time.
- (c) The consultant, after obtaining the completion certificate, is eligible to present the final bill for the work executed by him/it under the contract. The final bill shall be submitted by the consultant within 15 days from the date of issue of completion certificate, otherwise the Engineer-In-Charge's certificate of the measurement and of total amount payable for the work accordingly shall be final and binding on the consultant.

4.16 Final payment and Release:

- i. On completion of the work and issuance of completion certificate, the consultant shall submit his / its final bill indicating the gross and net amount payable. On receipt of this, the Company shall verify the same, determining the total value of the work done of the contract and after deducting all the sums already paid to him/it and/due to the company on any account and such further sums as the company on any account and such further sums as the company is already authorized or required to reserve or retain on the terms

of the contract or otherwise, makeover to the contract as his final payment subject to the Consultant furnishing a certificate to the effect that he has no further claim of whatsoever nature or description on the Company.

- ii. All prior certificate quantities, claims etc. upon which running account payments may have been made, shall be subject to adjustment in Final bill.
- iii. No claim shall be made or be filed by the consultant and the company shall not be liable to pay any money to the consultant, except as specially provided for in the contract. Acceptance by the consultant of the final payment as aforesaid shall operate as estoppels and shall be, a release to the Company from all claims and liability to the consultant in respect of anything done or furnished by the consultant for or in relation to the work, or in respect of any act or omission of the company or the Engineer-in-charge or any other person relating to or effecting the work.
- iv. Final payment including the security deposit will be released to the consultant on completion of work and after obtaining the approved Revised Mining Plan & Closure Plan from MoC.

4.17 Obligation of RSMML:

RSMML will provide Geological/Exploration/ Analysis data, Copy of earlier approved Mining Plan, EC and other relevant reports of technical studies, and latest surface Plan/Working Plan, & drawings.

RSMML has conducted following technical studies in past at Kasnau-Matasukh Mines:

1. Geotechnical Studies
2. Depressurization of Groundwater by NLC
3. Studies by CMPDI for Rehabilitation of mine Pits
4. Regional Hydrogeological Studies by CGWB

Reports of these studies are available with RSMML. In case consultant requires any data relating to aforesaid studies the same shall be provided for reference and guidance, if available.

Annexure: a- Compliance with the Code of integrity and No Conflict of Interest

Any person participating in a procurement process shall:

- (a) not offer any bribe, reward or gift or any material benefit either directly or indirectly in exchange for an unfair advantage in procurement process or to otherwise influence the procurement process.
- (b) not misrepresent or omit that misleads or attempts to mislead so as to obtain a financial or other benefit or avoid an obligation.
- (c) not indulge in any collusion, Bid rigging or anti competitive behavior to impair the transparency, fairness and progress of the procurement process;
- (d) not misuse any information shared between the procuring Entity and the Bidders with an intent to gain unfair advantage in the procurement process;
- (e) not indulge in any coercion including impairing or harming or threatening to do the same, directly or indirectly, to any party or to its property to influence the procurement process.
- (f) not obstruct any investigation or audit of a procurement process.
- (g) disclose conflict of interest, if any; and
- (h) disclose any previous transgressions with any Entity in India or any other country during the last three years or any debarment by any other procuring entity.

Conflict of Interest:

The Bidder participating in a bidding process must not have a Conflict of Interest.

A Conflict of Interest is considered to be a situation in which a party has interests that could improperly influence that party's performance of official duties or responsibilities, contractual obligations, or compliance with applicable laws and regulations.

A Bidder may be considered to be in Conflict of Interest with one or more parties in a bidding process if, including but not limited to:

- a. have controlling partners/shareholders in common; or
- b. receive or have received any direct or indirect subsidy from any of them; or
- c. have the same legal representative for purposes of the Bid; or
- d. have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the Bid of another bidder, or influence the decisions of the Procuring Entity regarding the bidding process; or
- e. the Bidder participates in more than one Bid in a bidding process. Participation by a Bidder in more than one Bid will result in the disqualification of all Bids in which the Bidder is involved. However, this does not limit the inclusion of the same subcontractor, not otherwise participating as a Bidder, in more than one Bid; or
- f. the Bidder or any of its affiliates participated as a consultant in the preparation of the design or technical specifications of the Goods. Works or Services that are the subject of the Bid; or
- g. Bidder or any of its affiliates has been hired (or is proposed to be hired) by the Procuring Entity as engineer-in-charge/consultant for the contract.

(1) Filing an appeal

If any Bidder or prospective bidder is aggrieved that any decision, action or omission of the Procuring Entity is in contravention to the provisions of the Act or the Rules or the Guidelines issued thereunder, he may file an appeal to First Appellate Authority, as specified in the Bidding Document within a period of ten days from the date of such decision or action, omission, as the case may be, clearly giving the specific ground or grounds on which he feels aggrieved:

Provided that after the declaration of a Bidder as successful the appeal may be filed only by a Bidder who has participated in procurement proceedings:

Provided further that in case a Procuring Entity evaluates the Technical Bids before the opening of the Financial Bids, an appeal related to the matter of Financial Bids may be filed only by a Bidder whose Technical Bid is found to be acceptable.

- (2)** The officer to whom an appeal is filed under para (1) shall deal with the appeal as expeditiously as possible and shall endeavour to dispose it of within thirty days from the date of appeal.
- (3)** If the officer designated under para (1) fails to dispose of the appeal filed within the period specified in para (2), or if the Bidder or prospective bidder or the Procuring Entity is aggrieved by the order passed by the First Appellate Authority, the Bidder or prospective bidder or the Procuring Entity, as the case may be, may file second appeal to Second Appellate Authority specified in the Bidding Document in this behalf within fifteen days from the expiry of the period specified in para (2) or of the date of receipt of the order passed by the First Appellate Authority, as the case may be.
- (4) Appeal not to lie in certain cases**

No appeal shall lie against any decision of the Procuring Entity relating to the following matters, namely:-

- (a) determination of need of procumbent;
- (b) provisions limiting participation of Bidders in the bid process;
- (c) the decision of whether or not to enter into negotiations;
- (d) cancellation of a procurement process;
- (e) applicability of the provisions of confidentiality.

(5) **Form of Appeal**

- (a) An appeal under para (1) or (3) above shall be in the annexed Form along with as many copies as there are respondents in the appeal.
- (b) Every appeal shall be accompanied by an order appealed against, if any, affidavit verifying the facts stated in the appeal and proof of payment of fee.
- (c) Every appeal may be presented to First Appellate Authority or Second Appellate Authority, as the case may be, in person or through registered post or authorized representative.

(6) **Fee for filing appeal**

- (a) Fee for first appeal shall be rupees two thousand five hundred and for second appeal shall be rupees ten thousand, which shall be non refundable.
- (b) The fee shall be paid in the form of bank demand draft or banker's cheque of Scheduled Bank in India payable in the name of Appellate Authority concerned.

(7) **Procedure for disposal of appeal**

- (a) The first Appellate Authority or Second Appellate Authority as the case may be, upon filing of appeal, shall issue notice accompanied by copy of appeal, affidavit and document, if any, to the respondents and fix date of hearing.
 - (i) On the date fixed for hearing, the First Appellate Authority or Second Appellate Authority, as the case may be, shall:-
 - (ii) hear all the parties to appeal present before him; and
 - (iii) peruse or inspect documents, relevant records or copies thereof relating to the matter.
- (b) After hearing the parties, perusal or inspection of documents and relevant records or copies thereof relating to the matter, the Appellate Authority concerned shall pass an order in writing and provide the copy of order to the parties to appeal free of cost.
- (c) The order passed under sub-clause(c) above shall also be placed on the State Public Procurement Portal.

Additional Conditions of Contract

1. Correction of arithmetical errors

Provided that a Financial Bid is substantially responsive, the Procuring Entity will correct arithmetical errors during evaluation of Financial Bids on the following basis:

- (i) if there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected, unless in the opinion of the Procuring Entity there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price shall be corrected.
- (ii) if there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and
- (iii) if there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to (i) and (ii) above.
- (iv) If the Bidder that submitted the lowest evaluated Bid does not accept the correction of errors, its Bid shall be disqualified and its Bid Security shall be forfeited or its Bid Securing Declaration shall be executed.

2. Procuring Entity's Right to Vary Quantities

- (i) At the time of award of contract, the quantity of Goods, works or services originally specified in the Bidding Document may be increased or decreased by a specified percentage, but such increase or decrease shall not exceed twenty percent, of the quantity specified in the Bidding Document. It shall be without any change in the unit prices or other terms and conditions of the Bid and the conditions of contract.
- (ii) If the Procuring Entity does not procure any subject matter of procurement or procures less than the quantity specified in the Bidding Document due to change in circumstances, the Bidder shall not be entitled for any claim or compensation except otherwise provided in the Conditions of Contract.
- (iii) In case of procurement of Goods or services, additional quantity may be procured by placing a repeat order on the rates and conditions of the original order. However, the additional quantity shall not be more than 50% of the value of Goods of the original contract and shall be within one month from the date of expiry of last supply. If the Supplier fails to do so, the Procuring Entity shall be free to arrange for the balance supply by limited Bidding or otherwise and the extra cost incurred shall be recovered from the supplier.
